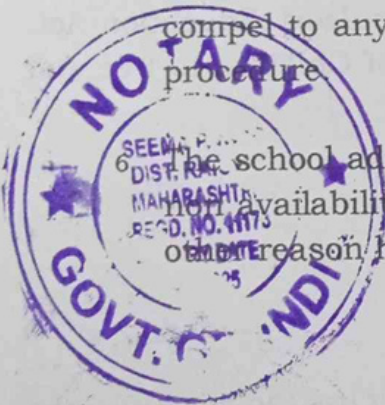
Sub: For granting Recognition Certificate to the schools for the purpose
of section 18 of the Right of Children to Free and Compulsory Education Act,
2009 and as per Sub-Rule (4) of Rule 11 of the Right of Children to free and
Compulsory Education Rules, 2011.

Respected Sir/Madam,

With reference to your application dated 27/05/2021 and the
correspondence made therein thereafter/inspection of school I the Education
Officer (Primary) Raigad Zilla Parishad, Alibag hereby grant temporary
recognition to M.A.D.P. School of the Former Member of Legislative Assembly
Dattu Sheth Patil Shikshan Prasarak Mandal Kamothe for English Medium
CBSE (school name with address) for 1st to 8th standard for the period of three
years commencing from 17/08/2021 to 17/08/2024. Above recognition is
subject to the following compliance. :-



1. Period of recognition will not be extended. There shall be no any obligation for recognition or association after 8th standard in any circumstances.
2. The school shall follow the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Appendix one) and as Right of Children to Free and Compulsory Education Rules, 2011 (Appendix Two).
3. The school shall give admission to the boys of adjoining infirmity classes and deprived classes in first standard up to minimum 25% of the number of students in that division and will provide free and compulsory education to them till completion of primary education. Moreover, another thing is that the said proportion shall also be followed for pre primary standards.
4. For the boys designated in paragraph No.3 the school will get reimbursement as per section 12(2) of the Act and for getting such reimbursement separate bank account will be given to the school.
5. Institution/School shall not recover any capitation fees and shall not compel to any boy or his or her parents or guardian for any scrutiny procedure.
6. The school admission shall not be refused to any boy for the reason of non availability of age proof, religion, cast or lineage, birthplace or any other reason herein.

7. (one) No any boy shall be kept in the same standard in which had been in the school or he shall not be removed till completion of primary education.

(two) No any boy shall be given punishment or mental harassment.

(three) No any boy is required to pass examination of any board till completion of primary education.

(four) Every boy who complete primary education shall be given Certificate determined as per Rule 23.

(five) Students who require handicap/ special assistance shall be included as per the provisions of the Act.

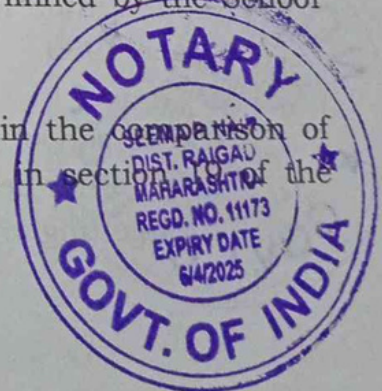
(six) The teachers holding minimum qualifications as per section 23(1) of the Act shall be appointed. Moreover, in addition to it the teachers who do not possess eligibility on the first date of this Act shall acquire such minimum qualification within the period of minimum five years.

(seven) The Teachers shall perform her/his duty incorporated in section 24(1) of the Act.

(eight) The teachers/madams shall not involve themselves in the work of private tuitions, the school will verify it.

8. The school will follow syllabus as per study determined by the School Appropriate Corporation.

9. The school will give admission to the students in the comparison of available facilities in the school as incorporated in section 10 of the School Act.



10. The School shall follow the standard and proportion incorporated in section 19 of the School Act.

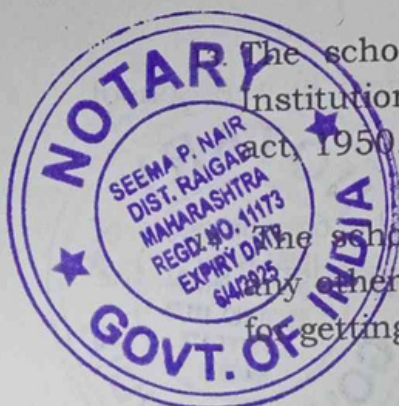
